<p><b>1. Name of policy/funding activity/event being assessed</b></p>	<p>The funding activity is a call for a Network Plus in ISCF Transforming Foundation Industries</p>
<p><b>2. Summary of aims and objectives of the policy/funding activity/event</b></p>	<p>The UK's Foundation Industries (comprised of Glass, Metals, Cement, Ceramics, Bulk Chemicals and Paper), produce 75% of all the materials in our economy and are vital for the UK's manufacturing and construction industries. The ISCF Transforming Foundation Industries programme will enable transformational change by these industries in how materials are sourced and processed, and the types of products manufactured, making them competitive and helping the UK achieve its ambitious Net Zero targets. The Network Plus investment will provide a new cross-sector and multi-disciplinary academic-led community for the programme that works together to address common challenges and accelerate the development and adoption of new technologies and business models within the Foundation Industries.</p>
<p><b>3. What involvement and consultation has been done in relation to this policy? (e.g. with relevant groups and stakeholders)</b></p>	<p>The call was developed following a community workshop held in June 2019, and in consultation with the ISCF Challenge team and EPSRC Business Improvement.</p>
<p><b>4. Who is affected by the policy/funding activity/event?</b></p>	<p>There are no additional eligibility criteria outside of that stipulated by UKRI and applicants are welcome from all career stages. There will be significant interaction with industry and the wider innovation landscape. Support staff will also be employed on the grant.</p>
<p><b>5. What are the arrangements for monitoring and reviewing the actual impact of the policy/funding activity/event?</b></p>	<p>Research outcomes will be collected through Researchfish. An EPSRC Portfolio Manager will be a member of the Network Plus advisory board. There will be additional monitoring and evaluation conditions as required by the ISCF Transforming Foundation Industries Programme. The assessment process is designed to ensure unconscious bias is minimised and managed.</p>
